AFFIDAVIT FOR REDUCED WATER/SEWER BASE FEE – SENIOR AND/OR DISABLED CITIZEN

COMES NOW _____ (“Affiant”) who being duly sworn on oath, makes the following statements and affirmations, which Affiant states are true and correct to the best of his or her knowledge and belief, for the purpose of obtaining the courtesy fixed reduction of the water/sewer base fee available to qualifying senior and/or disabled citizens as established by the Douglasville-Douglas County Water and Sewer Authority (the “Authority”) in its Rules and Regulations:

The Affiant, under oath, says:

1. The residential dwelling located at _____ is served by the Authority through a 5/8-inch or 3/4-inch water meter (the “Service Location”).
2. The Service Location is used solely as a residential dwelling and for no other purpose, including any commercial activity, business operation, or rental use.
3. Affiant resides at the Service Location and uses it as his or her permanent residence.
4. The annual gross household income of all persons residing at the Service Location, in the amount of \$ _____ for a household of _____ persons as stated by Affiant, is less than the currently published U.S. Department of Housing and Urban Development (“HUD”) “very low” income limit for the Atlanta Metro Area for the stated household size herein, as referenced in the Authority’s Rules and Regulations and available for review at <https://www.huduser.gov/portal/datasets/il.html> (HUD income limits website).
5. Affiant qualifies for reduction of the water/sewer base fee as (choose at least one):
 - ☐ Senior Citizen. Affiant, or at least one of the individuals responsible for paying the bill for water and/or sewer service provided by the Authority at the Service Location, is at least sixty-five (65) years of age, with a date of birth as _____ and current age being _____ years.
